**Eligibility Criteria for Application:**

1. Only Indian Nationals are eligible.
2. Eligibility Criteria is as per the Apprenticeship Act rules and regulations.

3. Admission shall not be claimed by any candidates as a matter of right. The admission shall be entirely at the discretion of the selection committee of the institution which may refuse to admit any candidates without any reason thereof.

4. The student should report to the office on or before 10 AM.


### **General Instructions:**

Candidates, who fulfil all the above conditions, will eligible for apply.

1. The duration of apprenticeship training is for one year.
2. Stipend paid as per apprenticeship Act.
3. Candidate should apply for apprenticeship through portal on or before 21.01.2022.
4. Selection will be through Interview selection committee.
5. Reservation of candidates will be as per the Government rules.
6. The shortlisted candidates will be informed for date of Interview and venue through E-Mail by their mail ID and schedule is uploaded in [www.igitsarang.ac.in](http://www.igitsarang.ac.in) website.
7. Must possess minimum age, educational and physical qualification prescribed for the trade as per the Apprenticeship Act rules and regulations.
8. Interested Candidate is required to register on BOAT's web portal [www.mhrdnats.gov.in](http://www.mhrdnats.gov.in) and apply for the Apprentices through the NATS portal. The application received after last date will not be considered. Students must carry their original academic credentials along with Biodata.
- 9. Please note that on completion of the period of apprenticeship training in IGIT Sarang, the apprentice shall have no claim whatsoever for any employment in this organization.**
10. During the period of apprenticeship, candidates will be governed by the 'Apprentices Act, 1961 and the policies/rules and regulations of the IGIT , Sarang.

Correspondence/Communication in any other manner will not be entertained.
12. During the training period the candidate will not be provided with hostel facility.
13. There would be regular assessment of their progress during the period.
14. Candidates must have registered their names at [www.mhrdnats.gov.in](http://www.mhrdnats.gov.in) & non-registered candidates are likely to be rejected.
15. The fresh pass-out candidates (passing their B. E / B. Tech / Diploma courses in 2019, 2020, 2021) only can apply as per rules and regulations of NATS. Candidate with post-graduation are not eligible to apply.
16. Those candidates who have completed the qualifying examination as regular candidates

are only eligible to apply.

17. The period of training will be 12 months commencing from execution of the contract of Apprenticeship.
18. Reservation will be applied as per the provisions of the Apprentices Act, 1961 and Apprenticeship Rules 1992 as amended from time to time. Applications belonging to SC (Schedule Caste) / ST (Schedule Tribe) / OBC (Others Backward Classes) - Non creamy layer shall produce their caste certificates in prescribed format issued by the competent Authority.
19. Selected candidates have to submit the "Medical Fitness Certificate" at the time of joining.
20. Verification of credentials shall be done prior to conduct of Personal Interview only and in case of any deviation from non-conformity with the desired qualification: candidature of the candidates shall be summarily rejected.
21. No TA/DA will be paid to the applicants called for any stage of the selection process.
22. The selected candidates must execute a Contract for a period of one year of training as per provision of the Apprentices Act, 1961 and rules framed there under.
23. Before applying, the candidates should ensure that he/she fulfills the eligibility criteria and other norms mentioned in the advertisement.
24. Suppression of facts will lead to disqualification at any stage of the selection process.
25. Any legal disputes pertaining to the Apprentice will be subjected to jurisdiction of concerned courts within the state of Odisha.
