



Memorandum of Understanding

BETWEEN

BOARD OF PRACTICAL TRAINING (EASTERN REGION), KOLKATA

AND

RAMAKRISHNA MISSION VIVEKANANDA CENTENARY COLLEGE, RAHARA

BOARD OF PRACTICAL TRAINING (EASTERN REGION), KOLKATA (BOPTER) and RAMAKRISHNA MISSION VIVEKANANDA CENTENARY COLLEGE, RAHARA (RKMVCC) enter into this agreement to facilitate the Apprenticeship training for the Pass out graduates and related issues like students' internship and job orientation for final year and pass out graduates which can be reached between the two institutions.

About RKMVCC

Our college is established on 1963, the birth centenary year of Swami Vivekananda . It is run and managed by Ramakrishna Mission. It has five (5) departments i.e. Chemistry (UG & PG), Botany (UG & PG), Physics, Zoology and Mathematics. Our college was accredited by NAAC in 2023 with Grade A++ (CGPA:3.8). In 2015 West Bengal State University has recognized our college as the Swami Vivekananda Centre for Multidisciplinary research in Basic Sciences and Social Sciences. In 2016 UGC has conferred the status of College with Potential for Excellence (CPE). Recently UGC has conferred our college the status of Autonomous College and the first session of the Autonomous status was started on and from 2017-18. MHRD, Govt. of India has announced the NIRF ranking where our college is placed 8th ranking in India in 2019.

About BOPTER

Established in 1968, Board of Practical Training (Eastern Region), Kolkata is an autonomous organisation under the Ministry of Education, Department of Higher Education, Govt. of India. The Board is functioning at its own premises at Block-EA, Sec-I, Salt Lake City, Kolkata-700064, West Bengal. The major function of the Board is to implement and monitor the provisions of the Apprentices Act 1961, as amended in 1973 and 2014 so far as they relate to the training of Engineering Graduates (Degree Holders) and Technician (Diploma Holders) in exercise of power conferred to the Board under the said Act.

1. Definitions

- i) For the purposes of this agreement "1st" institution shall mean BOARD OF PRACTICAL TRAINING (EASTERN REGION), KOLKATA (BOPTER), and "2nd" institution shall mean RAMAKRISHNA MISSION VIVEKANANDA CENTENARY COLLEGE, RAHARA (RKMVCC).

- ii) "1st" institute shall extend the support of conducting the orientation program through online or offline mode for the final year and passed out graduate students of our college for their enrolment in the Apprenticeship portal, so as to make them aware of about NAT Scheme of the Central Government including stipend policy, entry/exit policy in apprenticeship etc .
- iii) "2nd" institute shall ensure the students of the final year and pass out graduate students are enrolled in NATS portal for apprenticeship training every year, provide the space and other logistic support for conducting the awareness cum motivational workshop for the students.

2. Purpose of the Agreement

- i) The general purpose of this agreement is to establish a relationship and cooperation between the two participating institutions in order to develop the prospective skill of the pass out graduates so that they become a skilled and more employable human resource for industry or organisations.
- ii) The purpose of this agreement is to render services to the economically challenged and backward class students coming from rural and backward areas of West Bengal by means of developing their skill through Apprenticeship training.

3. Responsibilities of Participating Institutions and Students

- i) "1st" shall take the responsibility to support the awareness program for our final year and pass out graduate students in the college by means of conduct of seminar or workshop both online or offline mode.
- ii) "1st" shall take the responsibility to help the final year and pass out graduate students of "2nd" Institute for their enrolment process in web portal.
- iii) "2nd" shall take the responsibility to select the prospective final year and pass out graduate students, for awareness program in form of seminar or conference.
- iv) "2nd" institute shall provide the logistic support like space, etc to conduct such workshop or seminar in the field of apprenticeship training.
- v) "2nd" Institute shall provide a link of website of "1st" Institute on the prominent place on their website.

4. Period of Agreement

This agreement will come into effect from the date of signature by both parties, and will be valid for an initial period of six (6) years. The agreement will be automatically renewed on thereafter, unless terminated or replaced with a new agreement. The agreement may be modified or terminated by giving six months written notice to the other party.
