# AGREEMENT

Between

NATIONAL INSTITUTE OF TECHNICAL TEACHERS' TRAINING AND RESEARCH,  
KOLKATA

And

BOARD OF PRACTICAL TRAINING, KOLKATA

NATIONAL INSTITUTE OF TECHNICAL TEACHERS' TRAINING AND RESEARCH,  
KOLKATA (NITTTR-K) and BOARD OF PRACTICAL TRAINING-KOLKATA AGREE  
TO SIGN AN AGREEMENT.

Both the above being hereinafter collectively referred to as the Parties.

## 1.0 BROAD OBJECTIVE:

Recognize the mutual interest in the field of collaborative training and other related activities, dissemination of knowledge & skills for students and students.

## 2.0 SCOPE:

NITTTR-K and BOPT-K shall provide necessary support to each other in imparting quality training for students, teachers and industry personnel both in pedagogical and content areas (including management). Including imparting hands on oriented training.

### 2.1.1 Training for faculty and students:


The scope of the agreement shall cover the following items:

- i. Conducting on job Industry Attachment Programme for faculty/ professional.
- ii. GADP: General Aptitude Development Programme in identified attributes both in online and offline mode including
- iii. Training on professional skill development based on needs assessment as and when required.

## 3.0 FINANCE:

3.1 The cost of running any of the items mentioned in 2.1.1 would jointly be worked based on these scope and deliverables and shall be borne by concerned institutes / organization (here both NITTTR, Kolkata & BOPT(ER), Kolkata) / individual candidate. The details would be worked out on a case-to-case basis. In this regard Table 1 given in Annexure-1 may be referred.

3.3 The mode of payment, including advance payment wherever, applicable, shall be mutually worked out.



4.0 PERIOD OR VALIDITY OF THE AGREEMENT:

The agreement shall remain valid for a period of three years initially, starting from the date of signing the agreement. The agreement can however, be extended / renewed or terminated.

5.0 OPERATIONALIZATION OF AGREEMENT:

Specific project(s) or assignment (s) as mutually agreed upon by both the institutes and shall be identified mutually, in which the scope and the deliverable of the specific project shall be specified. Further, the cost of the same, mode of payment and the time frame shall be spelt out on a case-to-case basis.

6.0 FORCE MAJEURE:

Notwithstanding any item contained in this agreement, neither NITTTR-K nor BOPT shall be held responsible for actions beyond their control (e.g., natural calamity, law & order situation and so on) and no compensation shall be claimed by either party from other nor shall be paid.

7.0 ARBITRATION:


In case of disputes arising out of or related to any of the clauses contained in the agreement, it would be attempted to resolve the same bilaterally.
