




# FOREWORD

ince about last 50 years, Board of Practical Training, Eastern Region, [BOPT] under the Ministry of Education, Govt. of India is catering social service in Eastern Region of

the country by facilitating Apprenticeship Training to the freshly passed out graduate engineers and diploma holders in different industries and establishments for developing skilled manpower for their use. Thus, the service being provided by BOPT has a pivotal role in enhancing the skill of freshly passed outs Technical Graduates & Diplomas and Graduates in General Streams Pass Outs and making them more employable in todays modernised job platform.

The scope of NATS has also been expanded to include students from Humanities, Science and Commerce besides students from engineering stream. The scheme envisages training of about 8.57 lakhs students during next five i.e. from 01.04.2021 to 31.03.2026 for which the outlay of the scheme has also been enhanced to Rs. 3,054 crores on PAN India basis.

Govt. of India has set up "Skill Development Mission" with an aim to further manifestation of the Scheme to cover more and more aspiring students under the purview of the Scheme. While moving ahead, with the continuously increasing demand, National Apprenticeship Training Scheme (NATS) portal was launched by Ministry of Education, Govt. of India and process re-engineering has been continuously done as part of simplification of the registration process for industry and student. The portal is working effectively as virtual platform in facilitating the implementation of The Apprentices Act in the Eastern Region of the country with much needed ease.

Ministry of Education, Govt. of India, further directed to go for implementation of the Act for Industrial Training of B.Tech / Diploma Course pursuing students as Sandwich Course Apprentices. This initiative is expected to enhance the employability skill of freshly passed out Graduate and Diploma Students.

National Institute of Labour Economics Research and Development (NILERD), Govt. of India in 2019 was requested to conduct National Survey on Efficacy & Impact of National Apprenticeship Training Scheme (NATS). After conducting the survey, NILERD has submitted its report and the finding of the report says-"It is very clear from the findings of our study that the National Apprenticeship Scheme is very beneficial for the industries and apprentices. It helps in meeting the shortage of skilled human resource and provides current and future pool of human resource to the labour market. The scheme is unique as it is meant for technical personnel. It contributes to higher productivity of the establishment by supplying medium and higher level of industrially trained technical resource. National Apprenticeship Training Scheme (NATs) should continue with revised stipend rates approved vide Gazette Notification dated 25th September, 2019".





Most of the recommendations of the above study has been accepted by Govt. of India with the cabinet committee on economic affairs allotted Rs, 3056 crores of stipendiary fund for the next five years in the meeting held in November 2021.

The study suggests that the scheme may be expanded and more and more trainees in the existing / newer fields may be included under its ambit. The need of the hour is to utilize the available resources of the industry for skilling our young graduates by giving them on-the job training and making them employable. This will solve the problem of skill shortage on the one hand and employability of graduates on the other." With the increased target of training more than 1,00,000

apprentices during 2023-24 on account of Non-Engineering Graduates also included under NATS, BOPT has to adopt more innovative, concentrated and all out effort to reach to the target.

In this backdrop I am pleased to place before you the 'Action Plan & Program Calendar April 2023 – March 2024' to disseminate our yearly plans and activities along with a glimpse of some important events of 2022-2023. I request all the stakeholders to be apart of this endeavor in bridging the gap between demand and supply of the skilled manpower.

### **Highlights of Important Programmes**

# 1. Apprenticeship Cum Job Fair Organized by Board of Practical Training:

BOPT in association with the Department of science & Technology, Govt of Bihar conducted Apprenticeship cum Job fair (Centralized Selection) on 12th April 2022; 15th April, 2022; 17th April, 2022 and 20th April, 2022 at Taramandal, Adalatgunj, Bailey Road Patna. The main purpose of this program was to provide one year apprenticeship training to the students of Bihar after which the organizations will absorb the successful candidates as their employees. # 2. Training and Placement Officer (TPO) Meet on "Publicity and Promotion of NATS-way ahead"

BOPT strongly felt the need to have a close interaction with the Training Placement Officers of different institutes (both engineering & non-engineering) to seek their active support in increasing the awareness level among the final year students on NATS and hence BOPT organised

a TPO meet on promotion and propagation of NATS on 18th May, 2022 in the seminar hall of BOPT. The meeting was Chaired by Director, BOPT. Assistant Director conducted the meeting as a coordinator and Officer-On-Special-Duty as a moderator. Approximately 60 representatives of various technical and non-technical Institutes attended the meeting.

At the outset, after the introduction of the participants, Assistant Director, BOPT welcomed all the participants for joining the meeting and thanked all the principals, TPOs and faculty members for coming and attending the meeting all the way. During his deliberation he expressed why this meeting was necessary at that point of time and importance of it. He shared some important information before the gathering like the achievement in the financial year 2021-22 and the target for BOPT for the entire Eastern Region, opening of extension centers in different locations of the states, shiftment of NATS portal to new portal which is likely to be launched in the first week of June 2022. During his welcome address he also requested all the delegates to actively participate in the interactive session with their views and suggestions which is very important to chalk out the next action plan towards the promotion and propagation of NATS among the students community.

In his keynote address Director, BOPT conveyed his sincere thanks to all participants for extending their help to make this meeting happen. In his speech he expressed that the apprenticeship is one of the biggest bridge to connect the entire education and skill eco-system consisting of colleges, institutions and students who look for employment. He also mentioned that for last fifty years BOPT under the Ministry of Education, Government of India is catering to the need by implementing NATS for the passed out graduates and diploma engineers



in different Establishments/Industries through apprenticeship training. He emphasized on the requirement of skill development of freshly passed out graduates and diploma engineers as a whole. He advised all the TPOs of the Institution to encourage the students to enrol in NATS portal and to join apprenticeship training and the awareness should be spread in such a way that the supply side is so strengthened that the demand from the Industries should meet and match accordingly. Finally, he requested all dignitaries'/guests representing different technical and non-technical Institutions to come forward and join hands with BOPT towards implementation of The Apprentices Act for Graduate and technician apprentices.

Officer-on-Special-Duty gave a power point presentation explaining participants on the points to be discussed and requested the participants to take active part in the interactive session to express their views and suggestions on the mentioned points.

During the interactive session/question answer session the delegates from different Institutes actively took part and highly appreciated on the efforts made by the team of BOPT to create awareness among the students and also implementation of NATS by providing opportunity of apprenticeship training in different Establishments/Industries of Eastern Region. During discussion and interaction, the following points emerged:

- The Training Placement Cell of the Institute should organise Apprenticeship Day once in a year for their final year students where BOPT officials would address the students explaining them the benefits of joining NATS after passing.
- 2. Some activities like quiz contest, competition etc. among students may be organised jointly to reach the students more effectively and make them aware of NATS.
- 3. The Institution representatives shared that they will invite the BOPT officials on a mutually convenient date and time preferably on the Apprenticeship Day to conduct Career Guidance

Programme (CGP) for their final year students.

- 4. To increase awareness on NATS among the stakeholders including the pass out students (both engg. & non-engg.), the social media platforms like Facebook, Twitter, Instagram, YouTube etc. must be utilized.
- 5. All agreed that the strong collaboration among Industry-Institute and BOPT can fetch a better result in connection with the implementation of NATS

All the participants submitted their feed back on the topic in a format circulated by BOPT before the meeting. The same was collected for analysis.

The meeting ended with vote of thanks offered by Officer-on-Special-Duty to the chair.

- 2. As a first phase of operation towards implementation of NATS in their organisations the process would be as follows:
  - To enroll in NATS portal as an establishment.
     ... by 17th June 2022.





- To complete the process of engagement of apprentices. ... by 30th June 2022.
- To execute Contract of Apprenticeship (COA). ... by 8th July 2022.
- To forward the COA to BOPT for registration
   ... by 15th July 2022.
- 3. Those establishments who have already engaged apprentices may please submit the Contract of Apprenticeship (COA) to BOPT by 30th June 2022 for registration.
- 4. The COA will be created online by all the establishments once the facility of engagement of non-engineering Graduates is made available in the NATS portal.

The meeting ended with vote of thanks offered by Officer-On-Special-Duty, to the chair.

# 8. Workshop on "Roles and Responsibilities of TPA towards implementation of NATS"

BOPT organized a meet with the interested Third Party Aggregators (TPA) and non TPAs for a long term collaboration in order to implement and develop NATS on a wider scale for both freshly passed out Engineering and Non-Engineering students. The meeting was chaired by Director, BOPT, Kolkata. Director, Northern Board (BOAT) and Director, Western Board (BOAT) added glory to the same with their attendance. The meeting was attended by approximately 42 representatives of various entities. The representatives of various entities were welcomed by Officer-on-Special Duty, BOPT at the outset. He thanked all the participants for attending the meeting as well as for extending their help to organize the meeting.

In the keynote address, Director, BOPT and the Chairman of the meeting conveyed his sincere thanks to all participants and respective dignitaries of different entities for extending their help and cooperation to make this meeting happen. In his speech he expressed the importance of Skill Development and bridging the gap between academic and industrial environment. In addition, he mentioned in brief the view and mission of




A view of TPA workshop

Ministry of Education towards Skill Development of the youth throughout the country. He cited the importance of TPAs and their role in implementing NATS policy. He requested all the TPAs to come forward and join NATS so that a huge team of skilled and trained manpower is being made available as per the requirement of the industries /establishment.

Dy. Director, BOPT extended a PPT presentation with respect to NATS and related areas. He laid stress on the standard operating procedure of the same and how to exercise the implementation according to the guidelines available for all.

During the interactive session including fact related queries, the delegates from different entities actively made their participation and appreciated the efforts made by the team of BOPT towards implementation of NATS on wider scale. During the discussion and interaction the following points had emerged and representatives agreed on the same.

- i) The approval mechanism invites a number of layers.
- ii) The process of claim transfer is time taking on certain occasions.
- iii) There is more need to take the industries and students into confidence as far as the implementation of NATS is concerned as there is a demand supply gap existing in the market.
- iv) All TPAs are likely to enrol for as fast as possible in order to put into effect the policy at large.





v) All have been provided with the important operating provisions of The Apprentices Act and other details, covering clauses, eligibility etc. post which they can fill up the prescribed registration form.

Asst. Director(I), BOPT added few grounds and demonstration for TPAs should they collaborate with the concerned.

A concrete summarization giving focus on mobilization of the policy was placed by Asst. Director(III), BOPT, followed by a vote of thanks by the entire team.

The following resolutions were initiated:

- a) The supporting establishments must have at least one branch office/ unit of its establishment located in the Eastern Region.
- b) The NATS TPA must submit supporting letter of minimum 5 establishments within 15 days of issuance of provisional empanelment letter issued by BOPT and by end of first 60 days they must submit supporting documents of minimum 10 establishments.
- c) The NATS TPA must have adequate resources and strategies to mobilize different category of students matching with the demand of supporting establishments.
- d) The NATS TPA must fulfil all the eligibility requirements.
- e) The NATS TPA must be able to generate engagement viz. creation of Contract of Apprenticeship of minimum 1000 apprentices on a moving average every month from the date of issuance of provisional empanelment letter

The Board of Practical Training in association with the Department of Science and Technology, Govt. of Bihar conducted an Apprenticeship Cum Job Mela on 14th &15th July at Rastrakavi Ramdhari Singh Dinkar College of Engineering (RRSDCE) Campus & Govt. Polytechnic Campus, Ulao, Singhaul, Begusarai - 851134 (Bihar)

Apprenticeship Cum Job Mela was inaugurated by District Magistrate, Begusarai, Ex-Mayor, Begusarai, Dy Mayor, Begusarai, Training and Placement Expert, DST, Govt. of Bihar, Principal, Govt. Engg. College (RRSDCE), Begusarai & Director BOPT by the lightening of Lamp followed by Saraswathi Bandana.

BOPT organized a meet with the interested establishments for a long-term collaboration to implement and develop NATS on a wider scale for both freshly passed out Engineering and Non-Engineering students. Director, BOPT chaired the meeting. The programme was conducted by Assistant Director as a coordinator and Officer-on-Special-Duty, BOPT as a moderator of the programme. The meeting was attended by approximately 31 representatives of various establishments. The meeting was conducted in association with Ascensive Educare Pvt. Ltd., Deputy Director General, Bengal Chamber of Commerce and Industry was present as the guest of honour.

In the keynote address, Director, BOPT and the Chairman of the meeting conveyed his sincere thanks to all participants and respective dignitaries of different entities for extending their help and cooperation to make this meeting happen. In his speech he expressed the importance of Skill Development and bridging the gap between academic and industrial environment. In addition, he mentioned in brief the view and mission of Ministry of Education towards Skill Development of the youth throughout the country. In his speech he expressed that the apprenticeship is one of the biggest bridges to connect the entire education and skill eco-system consisting of colleges, institutions and students who look for employment. He also mentioned that for last fifty years this Board under the Ministry of Education, Government of India is catering to the need by implementing NATS for the passed-out graduate and diploma students in different Establishments/Industries through apprenticeship training. He emphasized on the requirement of skill development of freshly passed out graduates and diploma students.

Assistant Director, BOPT welcomed all the participants for joining the meeting. During his deliberation he expressed why this meeting is necessary at this point of time and importance of it. He shared some important information before the gathering like the achievement in the financial year 2021-22 and the target for the Board who are looking after entire eastern region, opening of extension centers in different locations of the states, the shiftment of NATS portal to new portal. During his welcome address he also requested all the delegates to actively participate in the interactive session with their views and suggestions which is very important to chalk out the next action plan towards the promotion and propagation of NATS among the students community.

Officer-on-Special-Duty, BOPT extended a PPT presentation with respect to NATS and related areas. He laid stress on the standard operating procedure of the same and how to exercise the implementation according to the guidelines

available for all.

During the interactive session including fact related queries the delegates from different entities actively made their participation and appreciated the efforts made by the team of BOPT towards implementation of NATS on wider scale. During discussion and interaction, the following points emerged:

- 1. All agreed that the strong collaboration among Industry and BOPT can fetch a better result in connection with the implementation of NATS.
- 2. To increase awareness on NATS among the stakeholders including the pass out students (both engg. & non-engg.), the social media platforms like Facebook, Twitter, Instagram, YouTube etc. must be utilized.
- 3. The establishments expressed their interest to enroll in NATS portal at the earliest
- 4. Some of the establishments were ready to hire apprentices at a large scale.



### EMPLOYMENT GENERATION THROUGH NATS-REGIONAL PERSPECTIVE

❖ National Apprentices Training Scheme (NATS) is implemented through Boards of Apprenticeship/Practical Training located at Mumbai, Chennai, Kanpur & Kolkata, which are autonomous organizations under the Department of Higher Education, Ministry Education. The scheme fulfills the gaps in the practical training of fresh graduate engineers, diploma holders engineering and also of the nonengineering degree students so as to them industry/establishment make ready. It further aims to improve their quality of industry/ commercial exposure and develop the technical human resource for the industries and establishments.



#### The objectives of the National Apprenticeship Training Scheme (NATS) are:

- to promote skill development and to bridge the gaps in providing the skill to the students who do not acquire during their study in colleges and thus to make them more employable; and
- ❖ to facilitate the employers to train disciplined and skilled manpower to meet the required human resources in the emerging areas. As per third party evaluation of the scheme by National Institute of Labour Economics Research & Development (NILERD) conducted in 2019, an autonomous organization under NITI Aayog, the post apprenticeship employment percentage under NATS is around 80% of total engagement. The employability percentage and details of students enrolled under NAT scheme is detailed below:

### 1.NEW INITIATIVES TAKEN (2022-23)

### 1.1 1ST YEAR OF IMPLEMENTATION OF NATS FOR NON-ENGINEERING GRADUATES

National Apprenticeship Training Scheme (NATS) is being implemented since 1973 under the provisions of The Apprentices (Amendment) Act, 1973 for Graduates and Diploma in Engineering & Technology. Ministry of Education, Govt. of India through its notification ref. no.F.No.13-7/2017-TS.VII dated 17.12.2021 decided to widen the coverage of the students from Engineering Graduates to Non-Engineering Graduates as well. Accordingly, target and financial allocation for 2022-23 was increased by 2.5 times to 60000 apprentices and Rs.100.00 Crores stipend outlay respectively. Since 01.04.2022, BOPT invited all such establishments who do not only require Engineering Graduates but Non-Engineering Graduates as well to join NATS and participate actively. Similarly, to disseminate the information amongst Non-Engineering Graduates, efforts were made through Department of Higher Education of different State Governments to reach to the Higher Education Institutes (HEIs) and their pass out students. In this endeavor certain State Govts. showed active response and it is through their intervention, the HEIs in some of the States have been able to nominate Nodal Officer to liaison with BOPT for extension of benefits of NATS for their pass out students. In this direction some of the State Govts. are vet to recognize the importance and make their HEIs connect with BOPT.

It has been noticed since long in the awareness building exercise conducted by BOPT, that the students once passed out generally dispense to different locations either for higher studies or for want of job. Under this circumstance, it makes highly difficult for BOPT to reach out such students. The mobilization of candidates in need for job or platform like NATS for grooming themselves so as to gain employment is an uphill task before BOPT. Students also do not wait after publish of their result, rather they plan subsequent steps of their career well before their final examination. Therefore, with lot of deliberation and discussion, it has been concluded that reaching to the final year course pursuing students and allowing them to do their enrolment in NATS portal is the best way of awareness building exercise. This is expected to help such students who do require the support of NATS, to plan accordingly for joining under NATS in some industries immediately

after publish of their results. The early enrolment of Graduates preferably during final year of their studies is also expected to benefit industries. It has been noticed that the industries are struggling hard to get students for hiring under NATS. It is also evident from the statistics of the job fair conducted by BOPT in the past. The number of students is not commensurating with the number of candidates intended for hiring by the industries participating in such Apprenticeship-cum-Job Melas. The early enrolment of the final year Graduates is expected to help the industries to call such students for selection interview etc. and make the panel ready with immediate joining subsequent to publish of the final year result.


The 1st year of implementation of NATS for Non-Engineering Graduates has been found to be largely affected due to want of aspiring students. In other words, mobilization of passed out students has been very difficult task inspite of several round of advertisement published through print media as well as on digital platform. Although with the efforts of the Third Party Aggregator (TPA), some of the new establishments have successfully enrolled and contributed in NATS. Inspite of high effort, BOPT could manage to extend benefit to about 25000 Non-Engineering Graduates in its 1st year of its implementation during 2022-23. The figure is unmatched in terms of passing out of about 45 lakhs of Non-Engineering Graduates every year in the Eastern Regional States of India.



Accordingly, BOPT has identified thrust area and planned to take up the awareness building exercise more aggressively during 2023-24 by targeting the final year pursuing Non-Engineering Graduates to enroll in the portal.

## 1.2 LAUNCH OF NATS PORTAL FOR NON-ENGINEERING GRADUATES.

Ministry of Education, Govt. of India vide its notification ref. no. F.No.13-7/2017-TS.VII dated 17.12.2021 issued order regarding inclusion of Non-Engineering Graduates i.e. General Stream Graduates such as B.A, B.Sc, B.Com, BBA etc. under the purview of The Apprentices (Amendment) Act, 2014. The responsibility for implementation and monitoring of such category of apprentices was also entrusted to BOPT and other Regional Boards. The number of Higher Educational Institutions (HEIs) offering such Degree course in Eastern Regional States of India are about 2700 and the average annual pass outs is about 45 lakh in number. Looking into high volume, the demand was expected to be about 5 lakh in the initial years. Accordingly, with the support of the I.T-Enabling Committee of the BoG of BOPT, a regional portal for Non-Engineering Graduates was developed and launched for public access on 15.08.2022. The portal

is the replica of MHRD NATS portal meant for Graduate and Diploma in Engineering & Technology. The portal provided a very much needed platform for the stake holders to transact the business digitally. In the first year, about 35000 Non-Engineering Graduates enrolled on the portal and about 25000 of such Graduates were provided facilities for apprenticeship. The portal is expected to run for another one year i.e. during 2023-24 with advanced facilities such as provision for enrolment of final year under Graduate students as well as for Sandwich course Engineering & Non-Engineering Graduates.

#### 1.3 APPRENTICESHIP-CUM-JOB FAIR CONDUCTED FOR STRENGTHENING OF NATS.

The financial year 2022-23 was the first wherein all Graduates in Engineering as well as Non-Engineering were covered for extension of benefit of NATS. Large number of such establishments who are not Engineering based, also got registered on the NATS portal. The demand of students through mobilization was one of the biggest challenges faced by BOPT during the year. Accordingly, it was planned to conduct Apprenticeship-cum-Job Fair in different part of the Eastern Regional States for providing opportunities for Engineering as well as Non-Engineering Graduates to get them selected in different establishments for initially one year apprenticeship training and then subsequent absorption on permanent basis. Although as per expectation the students' mobilization was found to be dissatisfactory in each of the fair held at different time,

#### 1.4 Website Development

#### **DEVELOPMENT OF NEW DYNAMIC WEBSITE**

The official Website of BOPT was Static and was very less Feature oriented, now the Dynamic website is developed with ample of Features which reflects various functions, activities, and Event organized by BOPT other than Apprenticeship Training.

The technologies used for developing the website are HTML5, CSS, Bootstrap, JavaScript, jQuery, PHP and CodeIgniter framework. For Database MariaDB and MySQL are used for fast fetching.

The Design of the website is Responsive compatible in all devices (Desktop, Laptop, Android, Windows, etc.)

The developed Website has an Eye-catching presentation, blended with up-to-date information, current data and information that can be viewed "LIVE" on Dashboard. The design and developments are done with latest technologies which reflects very impressive look & feel.

The website is developed in Tri language i.e., Hindi, English and Bengali (Local State Language) and has an on click audio facility that can be also accessible for visually impaired person also.

The Website is Security Audited by STQC and is integrated with SSL that makes the site secure.

Content Management System is also integrated with the Website for content upgradation.

### **2. THRUST AREA FOR 2023-24**

#### 2.1 Strengthening the Supply

During the year 2022-23, BOPT struggled to mobilize students, specially the Non-Engineering Graduates throughout the year as it is reflected in the low turnout of students during the Apprenticeship-cum-Job Mela as well as low enrolment on the portal. Accordingly, it has been decided that BOPT in the month of April, May & June, 2023 would extensively run the campaign to make the final year Graduates aware about NATS through developing connectivity on digital platform. It has been decided as a part of the strategy that the new video conferencing system developed at BOPT would be utilized to the fullest extent by creating and utilizing three slots of 2 hours each in a day and will be available for the institution, students to connect with BOPT. During the 2 hours program named "NATS Awareness Program" by inviting BOPT officials, Industry HR personnel and ex-apprentices for sharing information on NATS, industry expectations and success stories respectively shall be presented. It has been planned that out of about 2700 Non-Engineering Higher Education Institutions (HEIs), about 200 of them shall be covered in the first phase in the month of April & May, 2023. Subsequent months, will cover the rest of the institutions.

#### 2.2 Strengthening of Demand

It has been observed that about 2000 industries are registered in the Eastern Region on NATS portal out of which about 750 (37.5%) have been engaging apprentices in the recent past (within 3 years). Similarly, further analysis of data revealed that the percentage (%) seat utilization in these engaging establishments is about 35%. Accordingly, it has been planned to increase the establishment utilization to 70% and seat utilization to 90% in the engaging establishments during the year 2023-24. Two fold action has been planned for initiation – (a) the non engaging establishments must be strongly persuaded through written communications as well as visits so as to understand the importance of NATS and start engaging apprentices; (b) the establishments having low seat utilization shall also be informed about the fact and shall be requested to ensure that the seat utilization at no point of time during the year should be less than 90% of the quota decided for the said year. A strong monitoring system of number of establishments informed and rate of conversion from non-engaging to engaging establishments as well as percentage industry utilization and seat utilization throughout the year shall be developed and operationalized. Support from State Governments in regards to engagement of apprentices in State Govt. Departments and PSUs shall be obtained from different State Governments. State Govt. of Jharkhand, West Bengal and Assam who have not implemented the Act in their State Govt. Departments and PSUs shall be on the target for persuasion.






