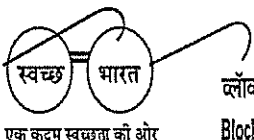

**Sub: Implementation of DBT in NATS in Phased Manner.**

Implementation of DBT was started by this Board from the month of December 2023 (Payable in January 2024) in some of the establishments who shared data in prescribed excel template. Difficulties are being faced due to incomplete data, mistakes in data preparation, bank accounts not seeded with Aadhar, accounts disabled for DBT and technical issues in NATS 2.0 portal. Issues were raised with the Ministry and all issues were discussed with the authorities on virtual platform. Accordingly, it is being informed that the DBT already started is hereby being discontinued till further notification. All establishments in eastern region under BOPT(ER) shall continue paying full stipend of January 2024 and subsequent months as used to pay during reimbursement mode. Further it has been decided that:

- (i) Initially DBT shall be implemented in PSUs and Government Organisations located in the jurisdiction of BOAT (Southern Region).
- (ii) The same shall be implemented in PSUs and Government Organisations of the remaining three BOPT/BOATs after successful implementation in BOAT(SR).
- (iii) Technical issues come into notice during initial months of implementation in PSUs and Government Organisations shall be fixed on priority.

- (iv) Private establishments shall be brought under DBT on receipt of satisfactory implementation reports in PSUs and Government Organisations and the same shall be notified to the private establishments at appropriate time.

The Establishments are requested to continue submission of reimbursement of stipend claim as per existing procedure (reimbursement mode) till further notification as per the above decision. Those who have already paid stipend to the apprentices through DBT must mention the months and amount paid through DBT by this Board in Covering letter/forwarding letter and the same shall be deducted from reimbursement claim till the time deduction facility is not made available in NATS 2.0 Portal.
