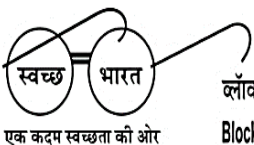
Dear Sir/Madam,

At the outset, I would like to extend my sincere thanks to the establishment and TPA fraternity for their active participation and contribution to the NATS by engaging apprentices in the year 2022-23. The year 2022-23 was a very challenging year for us as the target for implementation of The Apprentices Act 2014 & 2019 was extremely high and demanded all out efforts to achieve the mammoth target. This has opened the doors for the agencies/organizations having the requisite potentials and fulfilling minimum benchmark standards to support. Accordingly, Third Party Aggregators (TPAs) were invited and some of them having requisite potential have been empanelled as TPA. As a result, about more than 100 establishments across the Eastern Regional States of India have implemented NATS with the support of TPAs during last year (FY 2022-23).

Now, it has become important for BOPT(ER) to establish a direct communication/liaison system with the establishments, aiming for establishing direct communication with clarity and improved trust level.

In this process, it has come to the notice of the Regional Central Apprenticeship Advisor, BOPT(ER), Kolkata, that some of the TPAs while negotiating with the industry/establishments & students in the process, demands undue tangible or intangible favours from them especially, taking the name of the officials of BOPT. This includes the financial demands on the name of BOPT or any of its officials.

The above matter has been viewed seriously by the authority and it has become important to bring into the notices of you all. It is to be noted that BOPT or any of its Officials does not demand any sort of favour whatsoever for the services it intends to deliver to the stakeholders
