Notice for Graduate & Diploma holders passed out in Mining Engineering

Sub: Listing of students passed out Diploma in Mining Engineering in the FTP panel prepared by establishments under Coal India Subsidy.

Several e-mails and calls are being received from students aspiring to undergo Apprenticeship Training in Mining Engineering, specially in Coal India subsidiaries in the recent past. Apart from this, phone calls and e-mail communications are also being forwarded to the officials of Ministry of Education, Govt. of India on this subject. All candidates passed out diploma in Mining Engineering are hereby informed as follows-

- 1. Subsequent to migration of data from NATS 1.0 portal to NATS 2.0 portal, candidates' profile was required to be updated in NATS 2.0 portal. All such students have been informed through Public Notice in newspaper as well as through e-mails and SMS communications on their registered e-mail ids and mobile numbers by BOPT (ER) requesting them to ensure that their profile are updated on or before 29.12.2024. Some of the students are yet to update their profile, such students will loose their chances for appearing in FTP panel which is purely on the basis of seniority of the enrolment till they updated their profile on NATS 2.0 portal.
- 2. The FTP panel being prepared by establishments viz. subsidiaries of coal India work on the basis of seniority of enrolment. Accordingly, their seniority are recorded in the portal based on the date and time of enrolment in the portal irrespective of the fact when they have passed. The FTP panel reflects on the basis of seniority and as per the reservation policy implemented as per the notification of The Apprentices Act, 1961 as amended thereafter. The FTP panel preparation for Mining students commenced from 01.01.2025 as per previous notification. Coal India subsidiaries and others have already started panel preparation using FTP facility. In this process, students are likely to wait for their turn of appearing in the FTP panel, as such there is no manual intervention in this regard. Therefore, any complaints/grievances raised by the students will not alter the FTP preparation process as exist in the NATS 2.0 portal. Students are required to wait for their turn and they shall be accordingly notified as soon as they are listed in the FTP panel being prepared by different establishments. Students should refrain from filing complaints/grievances on this subject to the officials of Ministry off Education, Govt. of India or any other stakeholders.
