Sub: Implementation of DBT in NATS for PSUs and Govt. organizations located in the jurisdiction of BOPT (ER).

Reference to the DBT implementation process for the above subject mentioned category of establishments and earlier Notice ref. no. BOPT/DT/2023-24/825 dated 27.01.2024, all Govt. Departments & PSUs located in Eastern Region and registered in NATS portal under the jurisdiction of BOPT (ER) are hereby informed that the DBT implemented in similar establishments located under Board of Apprenticeship Training (Southern Region) have been found to be successful which was started in the month of February, 2024 for the payment of stipend for the month of January, 2024. Accordingly, it has been decided by the Ministry that the Govt. Departments and PSUs in the Eastern Region of the country registered with BOPT (ER) under NATS are required to implement the DBT for payment of stipend to the registered apprentices for the month of February, 2024 payable in the month of March, 2024. All such establishments are hereby informed to ensure DBT implementation as per the following guidelines:-

- 1. For all registered Graduate & Technician apprentices for whom the stipend for the month of February, 2024 are payable in the month of March, 2024, it must be ensured that the stipend for the month of February, 2024 for all registered apprentices are paid on or before 5th of the following month by the establishment excluding Central Govt. share of stipend. Their RoP must be entered into NATS 2.0 portal (if registered in NATS 2.0 portal) immediately after making payment i.e. on or before 5th of the following month.
- 2. For the apprentices registered in NATS 1.0 portal, the information along with the Loss of Pay etc. must be provided to BOPT (ER) in the Excel template (download template) available on the website of BOPT (www.bopter.gov.in) under Announcement Section and after making payment of establishment share, the same must be sent to BOPT through mail id shivamagrahari42.kb@karmayogi.in on or before 5th of the following month with a request for payment through DBT. On receipt of the same, BOPT will take necessary action to ensure that their payment through DBT is made at the earliest possible on receipt of the said confirmation mail from the establishments subject to display of their successful DBT registration on portal.

For those apprentices having warning messages apprentices must be informed to take necessary action at their end as per warning message and complete their successful DBT registration process at the earliest.
