Minutes of the Meeting of the Third-Party Aggregator (TPA) Meet conducted on 25/09/2024 in the "Smart Room" of BOPT(ER), Kolkata.

A workshop of the Third-Party Aggregator (TPA) in the EasternRegion was conducted on 25/09/2024 in the "Smart Room" of BOPT(ER) Kolkata. Directors/CEOs/ Representatives from 22 out of 35 empaneled TPAs in the Eastern Region attended the meeting. The list of invitees attended the meeting is enclosed herewith.

At the outset, the Director, BOPT(ER) welcomed all the participants and took up the agenda for discussion as mentioned below:

Action taken on the resolution of the previous TPA meeting held on 17/05/2024. The minutes of the meeting of the TPA conducted on 17/05/2024 was discussed in detail to ascertain the action taken on the resolutions adopted in the said meeting.

- 1. The performance of TPA partners for Second Quarter F.Y 2024-25 was perused by all the participants. It was found that except M/s. 2COMS Consulting Pvt. Ltd., M/s. Ascent Academy of Training and Development Pvt. Ltd. & M/s Spectrum Talent Management all other TPA partners' performance was un-satisfactorily. A detailed discussion was held on the subject, and it was decided that all TPA partners must ensure that by the end of third quarter, a minimum of 2000 more contracts must be created by each TPA.
- 2. Those sectors which have not yet engaged in NATS i.e, Insurance Sector, Banking Sector, Print media, BPO Sector, Security Company should focus on engaging in NATS.
- 3. BOPT shall now focus more on promotional meetings so every TPA needs to adhere to the committed practice of holding interactive meetings / sessions at least twice in a year where BOPT shall participate.
- 4. It was also found that each TPA partner was supposed to conduct one programme in each quarter at different places in eastern region on the topic of "Up-skilling of Current Training Facilities Under NATS". However, in the first, second i.e. April 2024 September 2024 only two TPAs were found to have conducted such programme. It was decided that in the last quarter this activity must be completed without fail.
- 5. Every TPA should try to engage the big number of hiring companies in NATS and if they deny for engaging then the Estab. details should be shared with the BOPT Officers, Officers will take necessary action.
- 6. All the TPAs are informed that for Direct Beneficiary Transfer ROP should be updated every month.
- 7. A detailed discussion was held on how to mobilize students. Every year a large number of fresh pass out students get admission in college out of which less than 10 per cent students enrolled in NATS.

- 8. Those TPAs who are not submitted PAN India letter for the PAN India compliance company wise to submit those letters to the respective Sections & Officers by email or post by 10.10.2024.
- 9. All TPA Partners are informed that they should share information to the respective officer on new establishment whenever it is onboarding on Portal.
