through online or offline mode for the final year and passed out graduate students of 2<sup>nd</sup> Institute for their enrolment in the Apprenticeship portal, so as to make them aware of about NAT Scheme of the Central Government including stipend policy,

entry/exit policy in apprenticeship etc.

"2<sup>nd</sup> "Institute shall ensure the students of the final year and pass out graduate students are enrolled in NATS portal for apprenticeship training every year, provide the space and other logistic support for conducting the awareness cum motivational workshop for the students.

#### 2. Purpose of the Agreement

i) The general purpose of this agreement is to establish a relationship and cooperation between the two participating institutions to develop the prospective skill of the pass out graduates so that they become a skilled and more employable human resource for industry or organizations.

#### 3. Responsibilities of Participating Institutions and Students

- i) "1<sup>str</sup> shall take the responsibility to support the awareness program for final year and pass out graduate students of 2<sup>nd</sup> Institution by means of conduct of seminar or workshop both online and offline mode.
- ii) "1<sup>st"</sup> Institution shall take the responsibility to help the final year and pass out graduate students of "2<sup>nd</sup> institute" for their enrolment process in NATS portal. (nats.education.gov.in)
- "2<sup>nd"</sup> Institute shall take the responsibility to select the prospective final year and pass out graduate students, for awareness building program in form of seminar or conference.
- iv) "2<sup>nd</sup>" Institute shall provide the logistic support like space, etc. to conduct such workshop or seminar or Apprenticeship cum Job Fair as requested by 1<sup>st</sup> institute.
- v) "2<sup>nd</sup>" Institute shall provide a link of website of "1<sup>st</sup> "Institute on the prominent place on their website.
- vi) "2<sup>nd</sup>" Institute shall attach promos of BOPT(ER) and its activities free of cost on the "2<sup>nd</sup>" official magazine (Hard Copy or Digital Copy).
- vii) RAD participation By Principal / Head of the institution of the "2<sup>nd</sup>" should be ensured.
- viii) 2<sup>nd</sup> Institute will participate in "GADP" through maximum number of final year students.

#### 4. Period of Agreement

This agreement will come into effect from the date of signature by both parties and will be valid for an initial period of one (1) year. The agreement will be automatically renewed thereafter, unless terminated or replaced with a new agreement. The agreement may be modified or terminated by six months' written notice to the other party.
