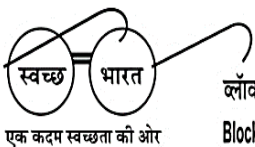

Notification

Sub: Implementation of Direct Benefit Transfer (DBT) in NATS for all Central/State Govt. Departments, PSUs as well as Private Sector Establishments.

All the Establishments (Central/State Govt. Departments, PSUs as well as Private Sector Establishments) having on-roll apprentices with active contracts on NATS 2.0 portal (only) are required to note the following information in relation to implementation of Direct Benefit Transfer (DBT) of Central Govt. share of stipend to the apprentices:

1. All the Establishments to please note that the active contracts of NATS 1.0 portal has already been migrated/shifted to NATS 2.0 portal.
2. The Central/State Govt. Departments, PSUs were already covered under DBT mode for sharing Central Govt. share of stipend to their apprentices having active contracts in NATS 2.0 portal for the stipend month of February 2024 paid in the month of March 2024 and thereafter.
3. In addition to the above, now all the Private Sector Establishments are being informed that they must not pay the Central Govt. share of stipend to such apprentices having active contracts on NATS 2.0 portal for the month of April 2024 payable from 01/05/2024 since after 01/04/2024 Private Sector Establishments are also required to initiate DBT payment request on NATS 2.0 portal so that it is processed by BOPT(ER) and the Central Govt. share of stipend is paid through PFMS mechanism to their apprentices under DBT mode.
4. With this all the Establishments (Central/State Govt. Departments, PSUs as well as Private Sector Establishments) registered with BOPT(ER) in NATS 2.0 portal will be required to ensure that the apprentices with active contracts on NATS 2.0 portal are paid Central Govt. share of stipend through DBT mode only.

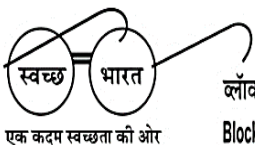
