Directors/CEOs/Representatives from 13 out of 27 empaneled TPAs in the Eastern Region attended the meeting. The list of invitees attended the meeting is enclosed herewith.

At the outset, the Director, BOPT(ER) welcomed all the participants and took up the agenda for discussion as mentioned below:

Action taken on the resolution of the previous TPA meeting held on 17/10/2023. The minutes of the meeting of the TPA conducted on 17/10/2023 was discussed in detail to ascertain the action taken on the resolutions adopted in the said meeting.

- 1. The performance of TPA partners for third quarter was perused by all the participants. It was found that except M/s. 2COMS Consulting Pvt. Ltd., M/s. Ascent Academy of Training and Development Pvt. Ltd. & Sri Jagannath Cultural Trust all other TPA partners are lagging behind in creation of the contracts. Detailed discussion was held on the subject and it was decided that all TPA partners must ensure that by the end of fourth quarter, minimum 1000 more contracts must be created by each TPA partners.
- 2. Those sectors which have not yet engaged in NATS i.e, Insurance Sector, Banking Sector, Print media, BPO Sector, Security Company should focus on engaging in NATS.
- 3. It was also found that each TPA partners was supposed to conduct one programme in each quarter at different places in eastern region on the topic of "Up-skilling of Current Training Facilities Under NATS". However, in the first, second & third quarter i.e. April 2023 January 2024 none of the TPA partners found to have conducted such programme. It was decided that in the last quarter this activity must be completed without fail.
- 4. Every TPA should try to engage the big number of hiring companies in NATS and if they deny for engaging then the Estab. details should be shared with the BOPT Officers, Officers will take necessary action.
- 5. All the TPAs are informed that for Direct Beneficiary Transfer ROP should be updated every month.
- A detailed discussion was held on how to mobilize of students. Every year a large number of
 fresh pass out students get admission in college out of which 10 per cent first year students
 should be engaged in NATS.
