Reference is invited to the above subject, you are requested to please make a note of the following for necessary action at your end-

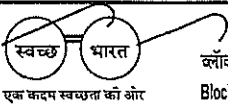
1. New Establishment Registration and New students Enrolment has been stopped at NATS 1.0 portal. Limited processing facility is available and the NATS 1.0 portal is further going to be downgraded with limited access to the stake holders for processing of claim reimbursement for establishments and CoP download for students.
2. NATS 2.0 portal has already been deployed with url mentioned on the subject above and is fully extended to all the stake holders and is fully adopted for all operations under NATS.
3. All new Establishments and Students enrolment under NATS is compulsorily to be made on NATS 2.0 portal only.
4. All stake holders viz. the establishments, institutions and students who enrolled on NATS 1.0 portal and have not reset their password on NATS 2.0 portal can log-in to NATS 2.0 portal with the e-mail id and password used by them for NATS 1.0 portal. They can log-in and verify/modify their details if required on NATS 2.0 portal.
5. Establishments who have re-set their password on NATS 2.0 portal can continue to log-in with their registered e-mail id and new password of NATS 2.0 portal.
6. In case, some of the facilities in the NATS 2.0 portal is found to be missing, the same may please be brought to the notice through e-mail to natssupport@aicte-india.org and copy to dydirector@bopter.gov.in
7. All NATS 2.0 portal related technical issues may please be sent to natssupport@aicte-india.org with copy to dydirector@bopter.gov.in
