- 2. **Matching QP/NOS**: It is crucial that the QP/NOS (Qualification Pack/National Occupational Standards) provided in the document are compared and aligned with the existing training modules of the graduate and technician apprentices employed by your establishment.
- 3. **Preparation of QP File**: In cases where suitable QP/NOS do not currently exist for specific job roles, your establishment is requested to prepare the QP/NOS and submit it via email to director@bopter.gov.in for review and further necessary action.
- 4. **Submission Deadline**: As agreed during our VC on 26 June 2024, establishments across different sectors are required to submit the document by email to <u>director@bopter.gov.in</u> no later than 10 July 2024, 5 PM.

Your prompt attention to these matters is highly appreciated, and we kindly request your cooperation to ensure the successful implementation of these skill development initiatives.
