

Memorandum of Understanding

Between

Director, Board of Practical Training (Eastern
Region) (BOPT, ER),
Government of India

And

State Apprentice Advisor (SAA) under the Department
of Technical Education, Training & Skill
Development (TET&SD), Government of West Bengal
(GoWB)

A. Objective

This Memorandum of Understanding (MoU) is signed between Board of Practical Training (BOPT), Eastern Region (ER), under Ministry of Education (MoE), Government of India, and State Apprenticeship Advisor (SAA) under the Technical Education, Training and Skill Development (TET&SD) Department, Government of West Bengal, for sharing of apprentice trainees' data under the National Apprenticeship Training (NAT) Scheme. This data exchange shall facilitate payment of additional stipend of WB-APS (West Bengal Apprenticeship Promotion Scheme) to the trainees required under NAT scheme as per Gazette Notification No.: I/4937 34 /2024 Dated 07/03/2024.

B. Scope

The collaboration under this MoU covers the following areas:

- Sharing of apprentice trainees' (whose domicile is in West Bengal) data under NATS.
- Data shall be shared as per the template annexed

- The shared data shall be uploaded in the designated portal (www.apprenticeshipindia.gov.in) wherein the apprentices will be required to apply by providing requisite information before approval/sanction of the stipend.

C. Roles and Responsibilities

BOPT, ER, Government of India

- Will be responsible for collecting and maintaining apprentice data (whose domicile is in West Bengal) enrolled under the NAT Scheme from the establishments and the institutions located throughout the country.
- Will ensure that the data is shared securely with SAA on monthly basis preferably within 15th day of successive month.

SAA under the TET&SD Department, Government of West Bengal

- Will ensure that apprentice data (whose domicile is in West Bengal) is collected in the prescribed format from BOPT, ER, as per the requirements of the WB-APS.
- Will coordinate with BOPT, ER, to resolve any discrepancies in the data and ensure timely disbursement of benefits to apprentices.

D. Data Protection and Confidentiality

Both parties agree to ensure the confidentiality of the data exchanged under this MoU. Data will be shared and used strictly in compliance with the applicable data protection laws and guidelines set by the Government of India.

The data shall not be used for any other purpose than the purpose of DBT (Direct Benefit Transfer) to the trainees as mentioned above.

This MoU is signed on by the Director, BOPT, ER, Government of India, and the SAA under the TET&SD Department, Government of West Bengal.


